



Cook County FY 2021 Preliminary Budget Hearing Testimony on behalf of Health & Medicine Policy Research Group Wesley Epplin, MPH, Director of Health Equity

Hi. I'm Wesley Epplin and I serve as the Director of Health Equity at Health & Medicine Policy Research Group, a supporter of the Cook County Health system.

I'm here to discuss the FY2021 Cook County budget forecast, which makes a preliminary commitment to the County health system of just shy of \$83 million, the same as last year. This is despite an expected budget shortfall of \$187.4 million for the health system.<sup>1</sup>

A major mistake from the last decade of this legislative body is severely and unsustainably cutting the county allocation to the health system: Reducing the local allocation from \$481 million in 2009 to the roughly \$83 million of today.<sup>2</sup>

That \$83 million doesn't even cover the Cook County Department of Public Health and the health services for Cermak jail.

We are in the midst of an historic, deadly pandemic. People are dying from COVID-19 every day, with a toll of thousands of people locally, and nearly 140,000 people nationally.

We have not sufficiently responded to this crisis as a country and the results are tragic and unjust, following a pattern of health inequity from structural racism.

While Cook County has had a slight reprieve, we've also had an uptick of COVID-19 in recent days and expect the pandemic to be with us for the foreseeable future. We cannot afford to let our guard down as others have done.

And we cannot allow our local safety net—anchored by Cook County Health—to atrophy or lose services from a lack of funding. You must fill the health system's budget gap.

Now, Cook County Health has just had dozens of layoffs and I've heard, more may be on the way.<sup>3</sup>

Imagine being on the other side of this pandemic, looking back, whether or not you want to have overseen the reduction in staff and service capacity at Cook County Health in the midst of a global pandemic. That is the budget choice before you today.

We have major health inequities, and many people struggled to get healthcare even before this pandemic, which has added burden.

Filling the health system's budget shortfall will not be an easy task, but cutting healthcare positions and closing units will worsen health inequities and is unacceptable.

Now, you might ask, where should you get the money? While that is your job to figure out, here's one suggestion.
