**Morning Concurrent Workshops #1 and #2**

**Workshop 1: Interviewing and Documenting**

**Time: 10:15 a.m. to 11:45 a.m.**

Learning objectives. This session is designed to help participants:

- Demonstrate how to interview patients and families in a non-threatening manner.
- Enumerate methods to be supportive and reassuring to patients and families.
- Practice open conversation with patients and families regarding immigration-related stress.
- Explain how to reassure patients and families that immigration status will not be documented.
- Describe how to provide documentation related to recording needs of patients for care and refugee status etc.
- Discuss tools and resources that providers, patients, and families might use.

**Workshop 2: Managing System Wide Change**

**Time: 10:15 a.m. to 11:45 a.m.**

Learning objectives. This session is designed to help participants:

- Enumerate the action steps suggested in the Public Health Awakened, Guide for Public Health Actions for Immigrant Rights.
- Describe approaches to making an entire facility and/or institution safer.
- Review how policies and practices might impact undocumented persons and their friends and families.
- Explain approaches to reviewing, revising, and writing policies designed to make patients and families safer within the health care setting.
- Review how to build support on issues important to patients and communities that include immigration.
- Identify Information Technology (IT) issues, (e.g. electronic medical records, WIC, and other electronic data).
- Practice how to build alliances between health/social service agencies and communities.

**Workshop 3: Creating Safe Spaces**

**Time: 12:15 p.m. to 1:45 p.m.**

Learning objectives. This session is designed to help participants:

- Review how to define and designate public and private areas in facilities.
- Explain why it is important to define private areas in facilities.
- Describe health and safety impacts of allowing fear to restrict access to care.
- Restate how to spot real "legal" warrants from administrative paperwork.
- Review how to make the registration process and information contained in computer systems safer and more secure.
- Illustrate what to say and do if ICE or other law enforcement appears at your facility.

**Workshop 4: Update on Legal Issues**

**Time: 12:15 p.m. to 1:45 p.m.**

Learning objectives. This session is designed to help participants:


- Describe relevant local and state and county laws: Illinois Trust Act, Chicago Welcoming Ordinance, Cook County ICE Detainer Ordinance and the recent attacks on "sanctuary" jurisdictions.
- Explain the legal loopholes in welcoming ordinances particularly the "gang database."
- Describe the different types of warrants and their implications.
- List the current legal protections for patients that do not depend on immigration status.
- Identify the rights & protections for health workers.
