Health Equity in Action: A Year of Impact

Dear Friends and Supporters,

In 2023, we re-dedicated our focus and our mission to build power and momentum for social justice and health equity in Illinois. Our board and staff worked hard to create this new



mission to reflect our commitment to action and movement building as the central building blocks of a more just and healthy society.

I am proud of what we've accomplished this year. In addition to the achievements you'll read about below, we've grown our staff and our board to better respond to new, immediate, and emerging public health challenges. Our multi-layered approach focuses on creating local and state

policy, education and training, and development of public systems that will support health.

We acknowledge that addressing structural and social determinants of health requires collaboration across disciplines, engaging the public, and developing relationships with elected and institutional leaders. This is hard and deep work, and our commitment is steadfast.

And we couldn't do this without the support of you, our community of friends, sponsors, and foundations, who share our vision.

This Year's Milestones:

Strengthening Workforce Development: We relaunched the Public Health Workforce Collaborative. As we continued to build policy and practice in support of this workforce, we worked to enhance health career pathways and build a stronger Community Health Worker ecosystem through learning collaboratives (32) and statewide policy.

Promoting Health Equity and Social Justice: Our advocacy has been pivotal in supporting policies and systems anchored in these principles. Initiatives like advocating for just cause in evictions and proactive rental housing inspections are key examples.

Advancing the Illinois Aging Together Campaign: We mobilized people across Illinois to develop an Illinois Strategic Action Plan for Aging Equity.

Advocacy for Public Health Funding: We've been vocal in demanding that elected officials provide adequate, flexible, and long-term funding for state and local public health departments.

Legislative Achievements: Health and Medicine's persistent advocacy for trauma-informed systems and supports led to led to the creation of the Task Force for a Healing-Centered Illinois, convened by Lt. Gov. Juliana Stratton. The Task Force is focused on transforming Illinois into a healing-centered, trauma-informed state.

Progress in Birth Center Licensing: Our Birth Center Task Force powered the coalition that forced the Illinois Department of Public Health to issue rules for Birth Center licensing. This achievement has led to the successful operation of four birth centers and the development of four more across Illinois.

Reflecting on our accomplishments and the challenges ahead, I'm filled with gratitude for our board and staff's courage to challenge norms and achieve transformative work. The task of confronting racism and structural health barriers is daunting, but I am confident in our collective strength and dedication.

I extend my heartfelt thanks to our collaborators and funders. Your trust and support fuel our mission. As we look to 2024, I am excited about what we can achieve together.

In unity and hope, we continue to shape a future where every individual in Illinois can flourish.

Our Impact

Public Health Equity Center

Our Public Health Equity Center helps us find new opportunities to live our values by working with key agencies and officials to make health equity a shared value, combating structural inequities, advocating for progressive public health policy reform, and providing training and technical assistance to grow the capacity of the public health system.

Through health organizing, collaboration, and narrative change, we build power for health equity. In 2023, the Center celebrated these key accomplishments:

- Supported increased local funding for both the Cook County and Chicago health departments. Presented testimony to Chicago's City Council Committee on the Budget and Government, and wrote an op-ed, *Chicago's Public Health Department gets alarmingly little funding from the city. That needs to change now.*
- Supported key housing initiatives in Chicago, including the just cause for evictions and proactive housing inspections ordinances.
- Launched project focused on enhanced capacity and collaboration among local health departments in Cook County
- Continued serving on the Partnership for Healthy Chicago, providing guidance on implementation of Healthy Chicago 2025
- Served as member of the Cook County Equity Fund Taskforce, providing input, feedback, and a public health perspective



Health Care Safety Net Center

Health & Medicine's Health Care Safety Net Center works to advance equitable health care as a human right for all people through policy research and development, advocacy, and engaged discourse on complex challenges.

This year, key accomplishments included the following:

- Advocated for strong support, outreach, and services to help Medicaid members going through the restarted redetermination process, including an op-ed, *We need to secure the right to health care for all Illinoisans.*
- Conducted a survey of service providers throughout Illinois related to readiness, plans, and funding needed to support Medicaid members through redetermination
- Advocated for increased funding for Cook County Health for the provision of health care for people who are uninsured
- Served on and chaired the Nominating Committee for the Cook County Health and Hospitals System Board
- Supported the Healthy Illinois Campaign work for the improvement and expansion of the Health Benefit for Immigrant Adults and Health Benefit for Immigrant Seniors Programs

"Do we want an America that stands with other wealthy countries to ensure that its people enjoy access to health care without bearing an undue personal financial burden? Or are officials more committed to bureaucratic obstacles intended to limit the number of people who qualify for government-supported health insurance? After a solid decade dramatically increasing the number of Americans with health insurance, does our country now want more people unable to see a doctor, unable to get their prescriptions filled, unable to afford tests and immunizations, and to further squeeze doctors and other providers who accept Medicaid and serve low-income communities? We don't think most Americans want that."

Aging Equity Center

The Aging Equity Center, formerly known as the Center for Long Term Care Reform, promotes equitable aging within communities for all Illinoisans at all ages. The Center works toward a just society that enables people to age well across the entire life course and an equitable system of long-term services and supports so that people can live according to their own goals and values, without exploitation or unmet needs. The Center advocates for caregiving that supports both the needs and rights of older persons and caregivers.

Highlights from this year include the following:

- Rallied supporters to file 160+ positive witness slips in support of the Aging Equity Act, which was re-introduced in the Illinois General Assembly
- Held roundtable discussions with five key demographic groups—Black, Latine, Asian, LGBTQ+, and people with disabilities—regarding their views on aging, including hopes, needs, and challenges
- Joined the new Fix Our Homes Illinois coalition, focused on developing statewide home repair funding and programming, including for older persons
- Continued growing the aging equity movement in Illinois through the Illinois Aging Together campaign at <u>www.illinoisagingtogether.org</u>

Illinois ACEs Response Collaborative

Health & Medicine is the lead convener of the Illinois ACEs Response Collaborative, a group of multi-sectoral stakeholders committed to expanding the understanding of trauma and its impact on people's lives. Through advocacy and mobilization efforts, we work to put the issues of adverse childhood experiences (ACEs) and resilience on the forefront of the equity agenda in Illinois. This year, the Collaborative made major strides toward our long-term goal of creating a trauma-informed, healing-centered Illinois, including the following key accomplishments:

- Led Illinois' fifth-annual Trauma-Informed Awareness Day, engaging over 300 partners, advocates, policymakers, and community members from across the state, representing diverse sectors and communities with a shared commitment to support resilience and thriving for all Illinoisans. The event featured a keynote address by Lieutenant Governor Juliana Stratton, highlighting her commitment to trauma-informed policy and systems change, followed by interactive breakout sessions on health, the criminal-legal system, youth and education, and community in which attendees shared their ideas and visions for healing in their communities.
- Developed and passed Senate Bill 646, establishing the Task Force for a Healing-Centered Illinois to support state and community-based agencies across multiple sectors to become trauma informed and healing centered.
- Reached 899 participants across 33 training sessions with 14 organizations, including seven free public trainings hosted by the Illinois ACEs Response Collaborative. We trained public health professionals, social service workers, public school teachers and social workers, and health care graduate students. Among these sessions, we presented at Chicago Public Schools' inaugural Healing-Centered Conference hosted by their Office of Social and Emotional Learning, developed a customized year-long series of our trainings for Cook County Department of Public Health, and shared a revamped session on burnout for community health workers through the HAP Foundation.

Chicago Area Schweitzer Fellows Program

For 27 years, the Chicago Area Schweitzer Fellows Program has provided a platform for graduate students to design and implement innovative projects that improve the health and well-being of under-resourced and marginalized populations throughout Chicago. In collaboration with existing community-based organizations, Fellows use a broad public health lens to improve well-being and target the social determinants of health. Not only do their projects promote positive change within Chicago communities, the practical on-the-ground experiences of the Fellows complement Health & Medicine's policy and systems work.

This year, our Chicago Area Schweitzer Fellowship Program continued to build a pipeline of health care professionals committed to social justice and contributed to the community by:

- Revising the Fellowship learning objectives and curriculum to align with program priorities and National Schweitzer Fellowship Chapters
- Inviting vital stakeholders to participate in comprehensive review of the Fellowship program intended to set the direction of future activities
- Guiding the 2022–23 Schweitzer Fellows to reach 2,178 community members through 6,021 hours of service
- Welcoming 28 new fellows into a program who are meeting in person again, post-pandemic
- Providing financial support to three Fellows for Life (program alumni) through Seed Grants to continue and expand their health focused community collaborations
- Supporting more than 750 Fellows for Life with networking, leadership, and educational opportunities through both our own chapter and in partnership with other Schweitzer programs across the country

Chicago Area Health Education Center

The Chicago Area Health Education Center (AHEC) works at the intersection of policy and practice to recruit, train, and retain a diverse health care workforce committed to under-resourced and marginalized populations.

Highlights of the Center's work this year include the following:

- Successfully trained over 100 direct care workers in active listening and advanced active listening skills for caregivers of older adults
- Developed active listening train the trainer and piloted the program with over 60 interprofessional health professionals in Southern Illinois
- Recruited a new cohort of AHEC Scholars and convened a webinar on migrant health
- Recruited and trained two cohorts of high school juniors and seniors for the CHW Youth Pathway Program
- In partnership with the Chicagoland Healthcare Workforce Collaborative, increased Speakers' Bureau professionals and disciplines to include a more diverse portfolio for Chicago Public Schools and other partners

Workforce—Community Health Workers

Community health workers (CHWs) are frontline public health workers who serve as trusted caregivers and are embedded in the communities they serve. Health & Medicine has a longstanding commitment to the CHW model, and we advocate at the state level and within health systems to strengthen the role and recognition of CHWs as integral members of the health care team.

Highlights from our work this year include the following:

- Successfully led the fifth year of our CHW Learning Collaborative Initiative in the Western Suburbs
- Supporting the Illinois Community Health Worker Association and the Illinois CHW Review Board as they work to support the CHW workforce, establish standard CHW certification, and operationalize Medicaid reimbursement
- Expanded learning and networking opportunities for West Suburban CHWs with the quarterly CHW Learning Lab
- Supported 14 organizations through the expanded Cook County Department of Public Health CHW Learning Collaborative model
- Presented at the National CHW Association Unity Conference with Sinai Urban Health Institute, the Cook County Department of Public Health, and private foundations of the West Suburbs on a partnership-building process for CHW sustainability

Workforce—Public Health Workforce Collaborative

Health & Medicine is the convener of the Public Health Workforce Collaborative (PHWC), a coalition of over 50 organizations working to build a unified, sustainable, and equitable public health workforce in the Chicagoland region. The Collaborative includes the region's local health departments, public health academic institutions, Federally Qualified Health Centers, funders and training providers, and community-based organizations, bringing together leading public health employers to identify shared challenges and collectively build and implement improvement strategies.

Highlights from this year include the following:

- Reconvening the PHWC with returning and new members and establishing a new mission, vision, and focus areas for our work together
- Launching three Action Teams that work on Supporting Workers, Building Career Pathways, and Growing Capacity and Funding Sustainability, respectively
- Building collaborative applications for the Good Jobs Challenge grant, which will cover tuition
 and related costs to train new and incumbent community health workers, doulas, midwives,
 behavioral health workers, EMTs, front-line FQHC workers, and certified nursing assistants
- Welcoming our sister table, the Chicagoland Healthcare Workforce Collaborative (CHWC), which supports workforce development in Chicago's large health and hospital systems, under the Health & Medicine umbrella
- Joining the CHWC in relaunching the Health Careers Youth Pathways Committee, which seeks to increase awareness and recruitment of young people into training opportunities and jobs in the health sector








Birth Center Task Force

For over 30 years, Health & Medicine's Birth Center Task Force has led the movement to establish and expand birth centers in Illinois. Birth centers provide an alternative home-like setting for pregnant people and their families to give birth outside of their home or a hospital following a normal, uncomplicated, and low-risk pregnancy. They offer cost-effective, high-quality prenatal care and obstetrical services along with other community health care services.

Health & Medicine has long championed the value of birth centers to provide cost-effective, high-quality prenatal and obstetrical services, offering birthing people and their families an additional option when choosing where to give birth in Illinois. We continue to serve as a resource and planning force for the continued development of legislation and establishment of birth centers to ensure that birth centers remain viable in the state.



"Due to the active involvement of the Illinois Birth Center Task Force of Health & Medicine Policy Research Group, there are now four Birth Centers providing care to birthing people in Illinois, with another four Birth Centers under development. Since 2012, there have been over 1000 babies delivered at Birth Centers in Illinois. Compared to hospital births, birth center care is consistently associated with lower cesarean rates, fewer medical interventions, higher rates of breastfeeding, and greater satisfaction with care."

Key achievements of the Birth Center Task Force include:

- Submission of extensive recommendations to the Illinois Department of Public Health relative to proposed Administrative Rules for the new Birth Center Licensing Act (PA 102-518)
- Fiscal sponsorship of the new Chicago Southside Birth Center, which will be led by Black midwives and offer professional healthcare and counseling services embedded in the local community
- Assisting in securing a small increase in the Medicaid reimbursement rate for birth centers
- Ongoing representation at the I-PROMOTE Illinois Maternal Child Health Task Force coalition to increase public awareness of birth and maternity setting options
- Ongoing representation, advice, and support of the recommendations to collaborative organizations for IDFPR (Illinois Department of Financial and Professional Regulation) proposed Administrative Rules for Certified Professional Midwives
- Completion of a UISPH project "Mapping the Key Events, People, and Politic," around describing the successful passage of the Birth Center Licensing Act in 2021
